

Guillermo Gaviria Echeverri **Tunnel**

In 2023, Guillermo Gaviria Echeverri Tunnel completed its breakthrough for the meeting of the two excavation fronts, making it the longest tunnel in the Americas. It will reduce the distance between Colombia's central region and the Atlantic coast, benefiting the agro-industrial sector, regional trade and boosting the region with new projects in the Urabá area of Antioquia.

Development credit:

We finance public investment projects and/or private law entities aimed at meeting basic needs to improve the community's quality of life.

We finance solutions for:

- Potable water and basic sanitation.
- Social infrastructure: health, education, housing, culture, sports and recreation.
- Road infrastructure.
- Energy, electrification, public lighting, gas.
- Multipurpose cadastre.
- Agricultural, forestry, and environmental development.
- Fiscal and financial adjustment plans.
- Machinery and automotive equipment.
- Institutional strengthening: development plans, territorial planning plans, institutional development programs, stratification and systematization.
- Investment in new communication and security technologies.

Treasury Credit:

We address temporary cash or treasury liquidity needs.

Benefits:

- Continuous support in the preparation and execution of the project.
- Flexibility and negotiation in payment terms.
- No prepayment penalty.
- No additional costs for credit administration.







Comprehensive advisory services:

We provide continuous support to territorial entities and their decentralized bodies to enhance their financial, administrative and budgetary management.

Our team of qualified professionals offers advice and support in public finance in accordance with current regulations.

We advise on administrative, financial and budgetary aspects, such as:

- Financial and fiscal strengthening.
- Preparation, presentation and execution of the municipal budget.
- Annual and multi-year investment plans in line with development plans.

- Evaluation of needs, priorities, and available resources according to the development plan.
- Support in the preparation of development plans, in coordination with departmental entities.
- Tax planning and support in fiscal adjustments and clean-ups.











2 Resource management

Demand deposits with and without supervision:

With immediate availability, where the generated interest is calculated and capitalized daily.

Term deposits:

Made with pre-established maturity periods, with a minimum duration of thirty (30) days.

Special funds:

Through inter-administrative agreements and contracts, we manage and disburse resources forstrategic projects.

Benefits:

- According to the planning principle, the resource is allocated for the specific project and in accordance with its execution timeline.
- Operational costs are reduced.
- We offer technical, accounting and financial support throughout the entire resource management process.
- Profitability of managed resources.
- Document management of the agreement, evidencing each action over time, such as budgetary supports, supervision reports, payment orders, deductions made and payment dispersal.
